**APPROVAL OF MINUTES:**

**HIGHWAY GARAGE STUDY COMMITTEE:**

Chairman Macy stated that the Town is looking for residents to serve on a Highway Garage Design Study Committee and anyone interested should contact the Town Administrator's office.

**SELECTMEN ITEMS:**

Selectman Hannum discussed contacting the Kiwanis Club regarding the ladder signs in Town.

Selectman Hannum stated that Sheffield will host the Southern Berkshire Chamber of Commerce Business After Hours in September.

Selectman Hannum noted that the Conservation Commission has approved the work for a canoe launch on the covered bridge property.

Selectman Wood noted that Mass Highway painted the crosswalks on Main Street today.

Selectman Wood discussed a request to have Sheffield declared as the Antique Capital of Massachusetts. The request will be forwarded to the Economic Development Committee.

Selectman Wood stated that she has received positive comments on the Town's new e-mail service for news and announcements.

**TOWN ADMINISTRATOR ITEMS:**

Administrator Kellogg stated that the roadside mower is broken and in the process of being repaired and he wanted to thank the Town of Great Barrington for the loan of a mower and operator for three days to catch up on some of the mowing.

Administrator Kellogg stated that billing letters will be mailed this week to all households regarding Transfer Station stickers for FY10.

Administrator Kellogg stated that the paving bid had been awarded to LB Corporation for Rote Hill and Hulett Hill Roads. This work will likely be done sometime in August. Letters will be sent to residents on East and West Roads stating the exact date for the oil and stone paving on those roads.

**PUBLIC COMMENT:**

Priscilla Cote inquired on the status of adding a grievance policy to the Town's Personnel Policy. Selectman Hannum responded that the Board will be working on this in the near future.

**OTHER BUSINESS:**

An application was received from Eric Carlson for a one day Wine and Malt License for a function to be held at the Town Park on August 23, 2009. Selectman Wood moved to grant the one-day Wine and Malt License to Eric Carlson for August 23, 2009 pending receipt of a certificate of insurance, seconded by Selectman Hannum. The motion carried unanimously.

Administrator Kellogg provided a draft letter to the U.S. Department of Commerce in support of the Massachusetts Broadband Institute's grant application for Broadband Technology Opportunity Program funding to expand broadband to Western Massachusetts residents. Selectman Hannum moved to send the letter of support, seconded by Selectman Wood. The motion carried unanimously.

Selectman Wood moved to adjourn the meeting, seconded by Selectman Hannum. The motion carried unanimously.

Chairman Macy adjourned the meeting at 7:17 p.m.
